

756 ASSEMBLY INSTRUCTIONS

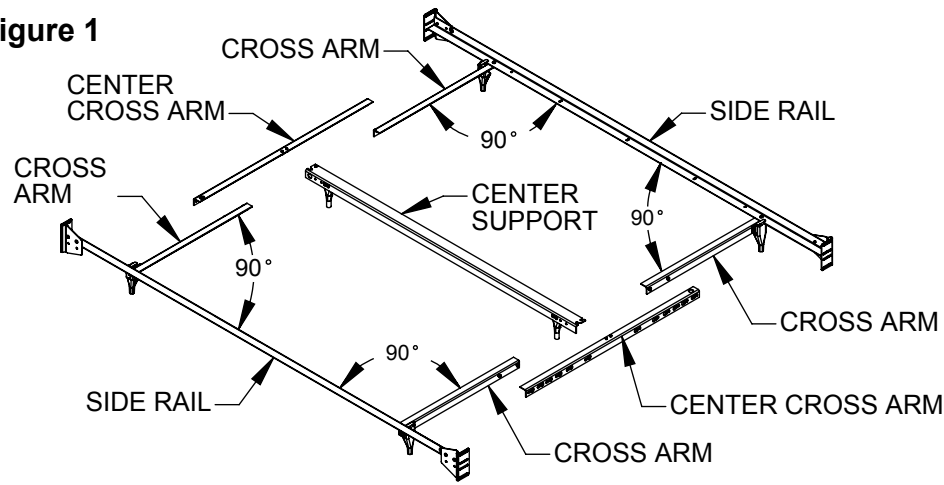

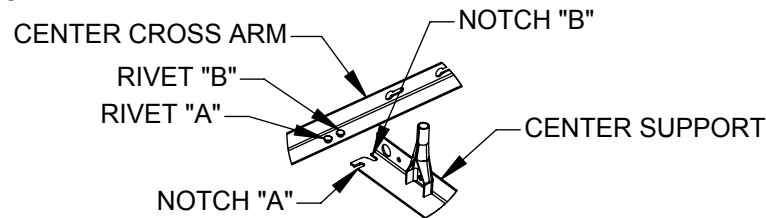

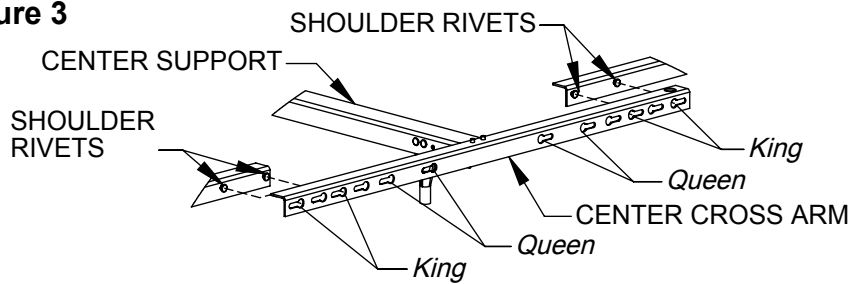

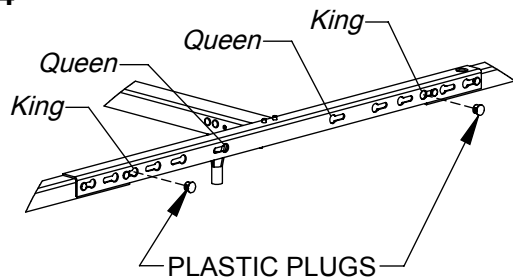

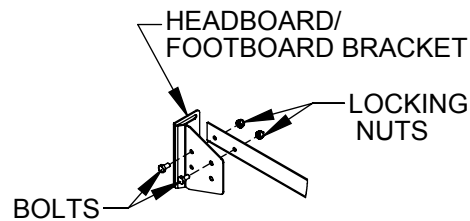
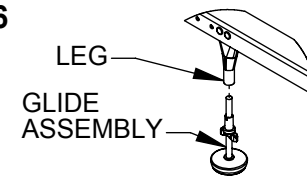

Step 1 Swing out CROSS ARMS 90 degrees as shown in Figure 1.

Step 2 Turn CENTER SUPPORT over with legs pointing up. Attach CENTER CROSS ARM by inserting RIVET "A" into NOTCH "A" then pivot so RIVET "B" locks into NOTCH "B" as shown in Figure 2. Repeat with other CENTER CROSS ARM.

Step 3 Overlap CROSS ARMS and engage SHOULDER RIVETS into proper keyholes as shown in Figure 3. **Note: Both rivet heads must engage in keyhole slots.**

Step 4 To lock cross arms together, insert PLASTIC PLUGS into openings indicated in Figure 4.

Step 5 For frames with removable headboard and footboard brackets: Attach BRACKETS using two BOLTS and two LOCKING NUTS per bracket as shown in Figure 5.

Step 6 Tap GLIDE ASSEMBLIES into LEGS of bed frame until fully seated. See Figure 6.

Step 7 Making sure glides are threaded up into legs far enough to avoid interference, attach bed frame to headboard and footboard.

Step 8 Adjust threaded glides so they touch the floor. Tighten all wing nuts. **Note: There must be at least 1" of the glide stem in the plastic insert.**

Leggett & Platt® Consumer Products Group ("LPCPG") warrants to the original retail purchaser ("Purchaser") that the LPCPG bed frame, center support system, bed rails, rollaway cot, top spring and/or pop up unit ("Product"), will at the time of purchase be free from defects in material and workmanship caused by LPCPG, subject to the terms and conditions set forth herein. This warranty shall apply for a period of one (1) year from date of purchase of the Product by the Purchaser from an authorized retailer. This warranty extends only to the Purchaser and may not be assigned or transferred. The Purchaser must be an individual who purchases the Product directly from an authorized retailer for the Purchaser's own single family residential use. If a buyer is not the Purchaser of the Product, he/she takes the Product "as is" and "with all faults." Proof of purchase will be required to demonstrate that buyer is the Purchaser and eligible to make a valid claim under this warranty. In the event of a breach of this warranty, upon timely notice during the warranty period, LPCPG's sole obligation shall be to, at LPCPG's option, either repair or replace the Product or allow credit in the amount of the purchase price for the Product. Repair, replacement, or a credit allowance shall be the sole and exclusive remedy under this warranty. To take advantage of this warranty, return the defective Product to the store where purchased. If the seller has moved or gone out of business, contact LPCPG directly for claim submission at either the website or the telephone number provided in the last paragraph of this warranty. Any transportation, shipping and handling costs, and the risk of loss during transit, shall be borne by the Purchaser. Repairs to or exchange of a Product under the terms of this warranty will apply to the original warranty period and will not serve to extend such warranty period. LPCPG will not be responsible for repair, replacement, or credit where damage to the Product has been caused by (i) abuse, negligence, improper installation, or misuse of the Product; (ii) acts or omissions of any person or entity other than LPCPG; (iii) institutional or commercial use; or (iv) acts of God or other natural forces.
